STARLIGHT RIDGE HOMEOWNERS ASSOCIATION ARCHITECTURAL APPROVAL APPLICATION FOR LANDSCAPE CHANGE

To streamline the application process here is a list of what you will need:

- Step 1 Print the application from the web site and fill out
- Step 2 Draw a plot plan with your house and address
- Step 3 Add to your drawing any hardscape (concrete or stone)
- Step 4 Add to drawing plants & ground cover, include number of each type.
- Step 5 Is the plant schedule which lists what plants will be used.
- Step 6 Go to your neighbors Homeowner (no tenants) and get them to sign
your Neighbor Awareness Statement which is page 3 of your application.
- Get approval from the board before any work starts.

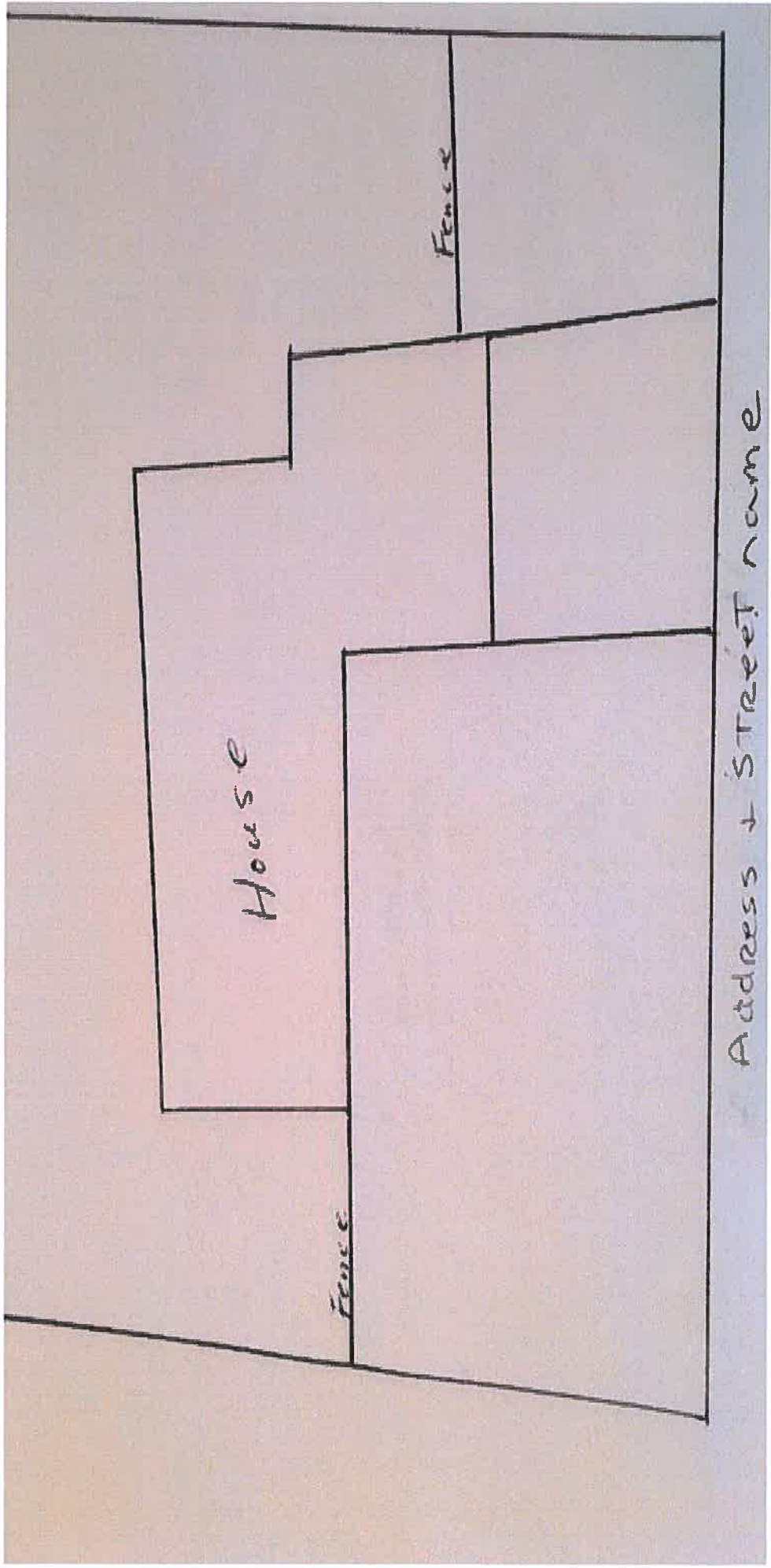

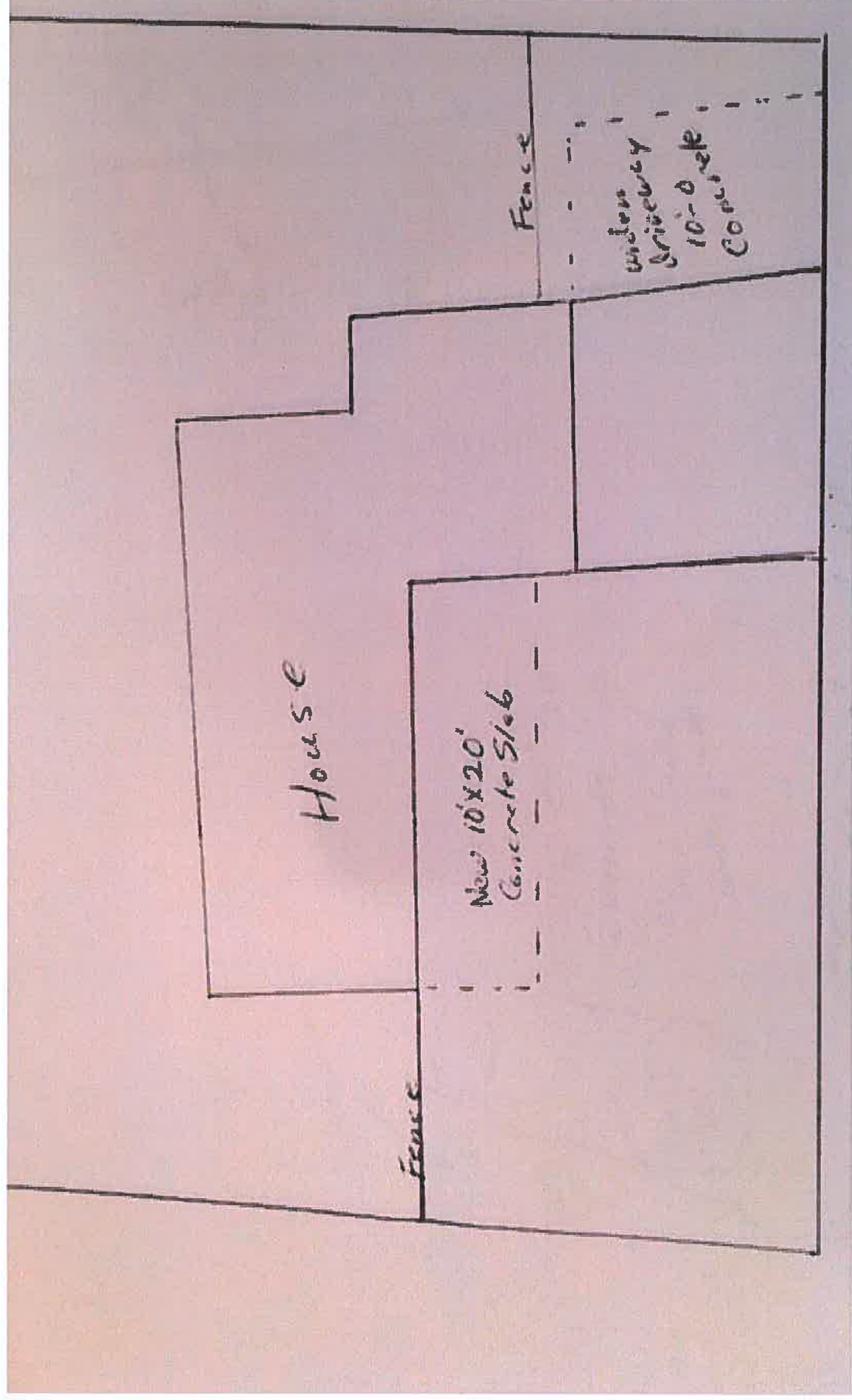

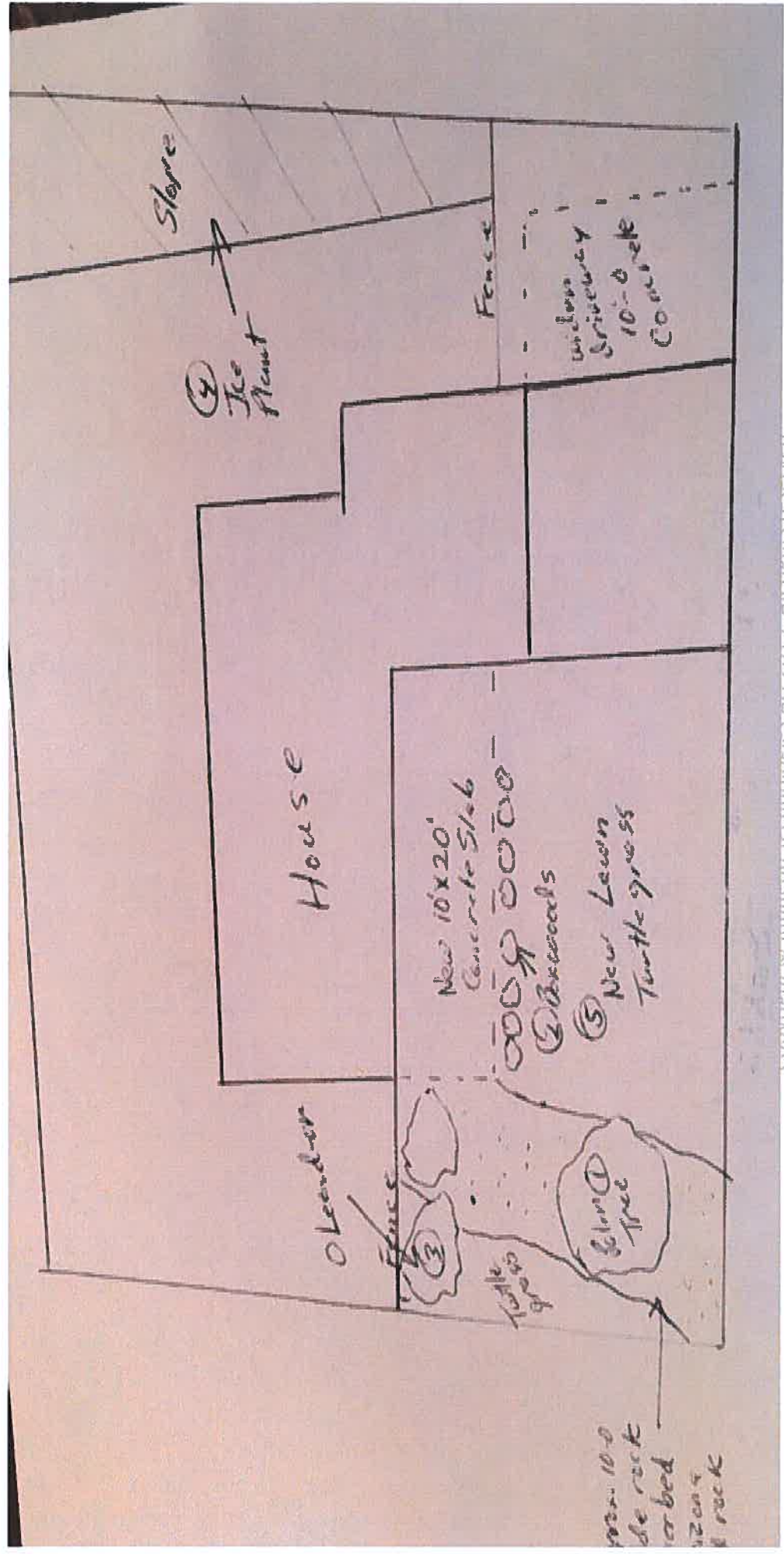
